TERMS AND CONDITIONS

_____The renter agrees to make all rental payments on time for each rental period through automated billing.

_____The instrument rental contract goes into effect on the date in which it is signed. Contracts signed during the 1st-15th of each month will be billed on the 1st of the following month. Contracts signed during the 16th-31st of each month will be billed on the 15th of the following month. Automatic payments will be set up for your convenience; there will be a \$25 fee for all declined electronic payments.

_____Should an instrument be returned prior to the completion of the contract, an early termination fee of \$25 will be applied. Any damages beyond normal wear and tear to the instrument will also be subject to additional charges.

_____Monthly billing will require a major credit or debit card; cash will be accepted for initial payments only. All credit card information will be kept on file only for the purposes of collecting payment on rental instruments. Bank account information can also be left if the renter so chooses.

_____Should the account exceed 60 days past due, the contract will go into default and we may terminate the contract and charge your credit card for any outstanding balance. You will be responsible for the price of the instrument plus all other costs including any legal fees associated with collecting payment for the instrument. Return of the instrument as credit towards this obligation will no longer be accepted.

_____The contract period for Rent-to-Rent is 10 months in length. If the renter wishes to continue after the initial contract period, the option to extend is offered as needed.

_____Instrument rental contracts to individuals under the age of 18 MUST be accompanied by a parent/legal guardian signature.

_____Payment schedules will be provided if requested.

_____All rental instruments have been inspected to ensure that they are in good playable condition. It is recommended that the instrument be inspected and tested for damages at the time of pickup. The cost of damages is the responsibility of the renter after the instrument is turned over to them.

_____The parent/legal guardian is advised to carry personal insurance against loss, theft, or damage to the instrument.

_____The renter is responsible for the instrument during the contract period. Should the instrument be stolen, lost, or damaged within the contract period, the renter is responsible for the full cost of the instrument. In order to file a claim and recoup the instrument's value, a reported stolen instrument must show a police report as proof and a breaking must have occurred; this will provide the renter's home or auto insurance (whichever may be applicable) adequate proof of theft and allow the renter to fully reimburse The Music Center. Loss of instrument due to neglect is not covered.

_____Rent-to-Own instruments can be upgraded to step-up models at any point during the contract period and any equity accrued (minus the maintenance fee) can be applied towards the new contract; transfer credit will only be applied if the initial instrument is returned in good working condition.

_____Returning the rental instrument to the band director does not release you from this contract. The rental instrument must be returned to The Music Center, 795 West Main Street, Suite B, Bridgeport, WV 26330.

_____The monthly maintenance fee covers general maintenance and upkeep of the instrument including but not limited to: pad replacement, stuck mouthpieces, soldering, and replacing screws. This does not include cleaning the instrument or providing accessories. Accessories include but are not limited to: reeds, valve oil, ligatures, straps, or polishing cloths. Malicious damage is not covered under the maintenance fee.
